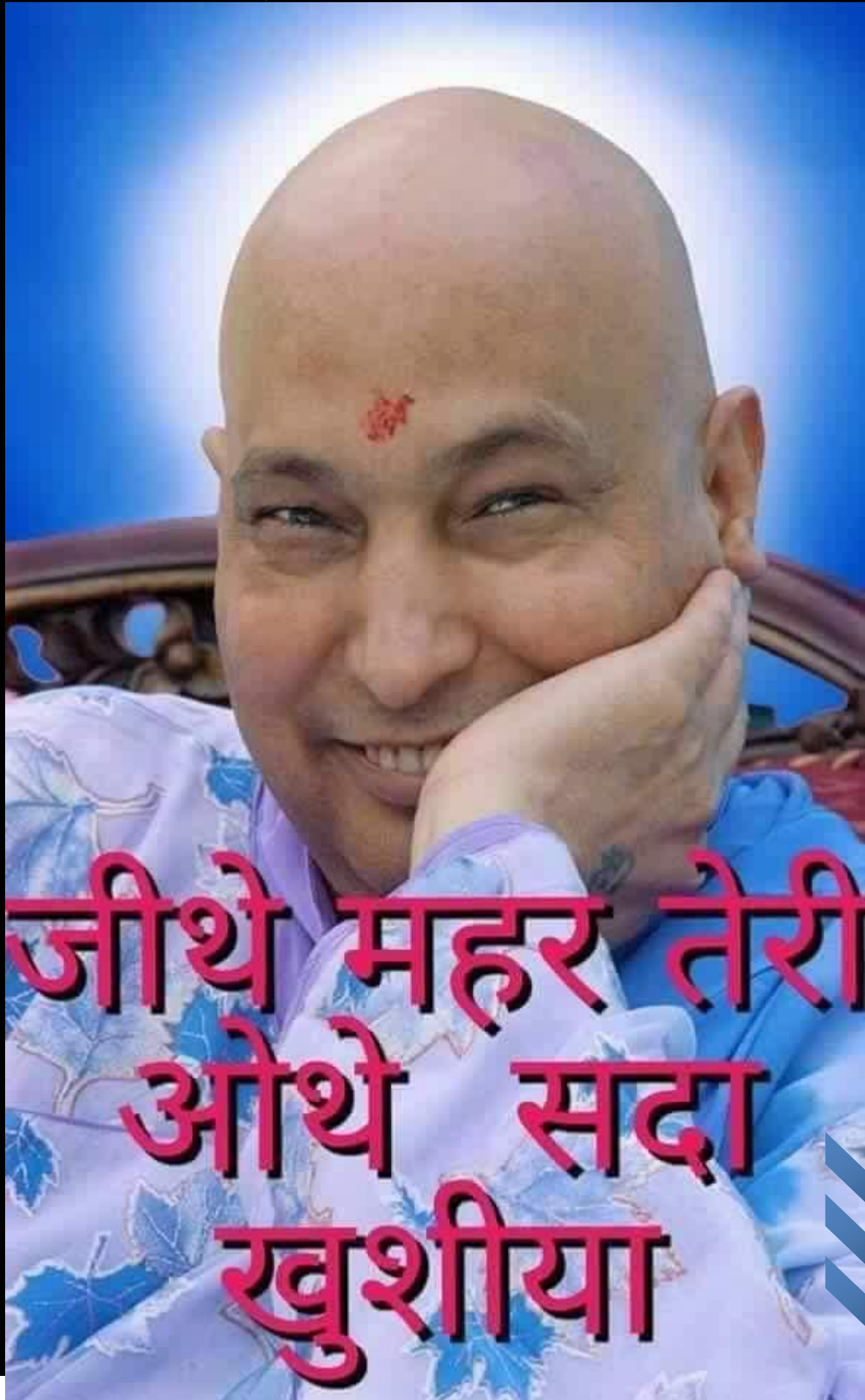

Satsangs:

1. First Darshan of Guruji ka Ashram (Bade Mandir)

I am a disciple of Lord Shiva for more than 16 years. I have been praying and doing 16 somvar fast a number of times since 2000. Lord Shiva blessings are always with me all the times.

I have come to know about my beloved Guruji through my cousin sister Kavita and went to the Bade mandir with my daughter Bhumika, my brother Manav Pooja bhabhi and my nephew Utkarsh and my cousin sister Kavita along with her three friends aunty on 3rd August, 2012. The day was the luckiest day of my life who changed my life completely. I was undergoing through very difficult phase at that time. My Lord Shiva and my Guruji called me on that day and made me his disciple for not only this life but for the coming lives. We had langar Prasad and got the shabad CD of Sada Thakur and Massom Thakur. Next day I came back to Mumbai with my daughter Bhumika.



2. Guruji Stabilise My professional Life:

I started listening Shabad CD and feel relaxed. I got the inner peace after listening the CD. My cousin sister Kavita called me and told me that I am coming to Mumbai and I have to do the Satsang. At that time she was doing the monthly satsang at her home on every 11th and she is coming to Mumbai on 8th September, 2012 for delivering Geeta Upnishad Lecture at Borivali along with her colleague. I told her that we can do satsang at Mumbai, but I don't know how to carry out. Then she searched out the sangat at Mumbai on facebook and She got the number of Inderpreet Uncle at Mumbai. She called Interpret Singh Uncle that she wants to do satsang, Uncle told that there is monthly satsang is carried out at Mumbai and tomorrow is the Satsang at his place at Santacruz. We went to attend the satsang on 9th September, 2012 at Inderprit Uncle house and it was a blessed satsang. I got the sukhi aunty book " Surcharged with Divine Love" which was distributed in the Satsang.

On 7th September, 2012 I receive a call from my Regional office Incharge that somebody has made complaint against me and it is a vigilance matter. He also told me that you have to visit and carry out inspection at Regional Agmark Laboratory, Kochi on 10th and 11th September, 2012. I went for Inspection and I told my sister that we will do satsang on 12th as I have to leave on 9th September, 2012 after attending the satsang. Kavita aunty take some sangat mobile number and called for satsang at 4pm on 12th September, 2012. One Guruji sangat Pooja aunty staying at Borivali brought Guruji Sawaroop and Kada Prasad and we arranged samosa Prasad and chai Prasad and satsang was held in Borivali hall booked for Geeta upnishad path. I went to office on 13th September, 2012 and went to meet Regional Office Incharge and discussed the matter and he came to conclusion that it is a false complaint and sent the report to Head office, Faridabad. Guruji disposes the matter by attending the satsang and arranging satsang. Guruji knows the problem in advance and dispose off the same by the satsang.

Guruji's Satsang are so powerful who can do anything by cleaning your soul, clearing your karma, removing obstacles in your life, healing the diseases and preventing the diseases by changing the aura of not only your body but also the surroundings and fill up the surrounding either home or office with positivity. Shukrana Guruji for stabilising my professional front.

3. Guruji Stabilises my Personal Life

I got married in 2006 in Delhi and my daughter was born in 2007. When daughter was born, the quarrel started between my husband and myself and he started saying me Go to your parent house. Saying converted into abusive language and then physical abuse started . He started beating me. My father in laws and Mother in laws also started supporting him and

abusing me in one way or the other. At that time I was working in a private laboratory at Dwarka, Delhi. I am not able to tolerate all this and went to my parents house. I got Government Job and my posting was at Mumbai. I shifted to Mumbai in 2011. I was staying at Ghatkopar and want that my husband should realise and come at Mumbai and we should be happy. I have gone to several pandit and astrologers and has got some stones and some mantra for jaap and everybody told that he will come and stay with you if you do all these jaaps etc. However, I did not have peace of mind. I completed all Poojas and vrat and jaap as per Astrologers and pundits etc and came to Delhi. Pandit told that you should meet him there then everything will be all right. It was August 2012. I called my husband but he denied to meet me. I went to Bade mandir on August 3, 2012 and had langar Prasad there and came back to Mumbai. I was very disappointed but when I play the CD it was so soothing and I got Sleep. I got inner peace that I have not realised in so many years. I fell asleep after listening the shabad.

I was not able to understand what to do where to go. But one thing I realise that my husband has rejected me but my Guruji (My father) has accepted me. I lost my father in 2010 and since then I missed him so much. Guruji took me in HIS Sharan and I feel inner peace.

After attending the Satsang at Inderprit Uncle house, I have been added as sangat and I started getting alerts regarding the satsangs in Mumbai and we went to attend the satsang wherever it is as I got inner peace as if it is a magnet. My daughter Bhumika also started enjoying the langar Prasad. Guruji started giving me indication that I should file Divorce but I was not able to take decision and has not filed any case against him. I used to carry out my official duties and taking care of Bhumika and attending the Satsang.

I filed the Domestic Violence case against him in May 2013 at Vikhroli court but from inner heart I loved him so much so I did not took so much interest in Court case and taking dates every month. However, my husband Aryavrat Sharma was very mean and shrewd and he gave money to my lawyers. My lawyers were not in favour of mine and said you will not get any money. One lawyer who was very trust worthy even did not come on the date of Argument. Then I myself took the matter and told Judge that I will do the Argument for my case and myself defend the case. I am not a professional lawyer and no LLB Degree. I am M.Sc and PhD in Microbiology and defend the case. I don't know how I did. I just started speaking by Jai Guruji. Guruji's put words in my mouth and it was the best Argument as there were many lawyers sitting in the court who listen my argument and the Judge put the case in my favour. Domestic violence was proved against my husband Aryavrat Sharma and maintenance of Rs 15000/- per month for my daughter was fixed up by the Vikhroli MM Court. It was December 10, 2014 when the order was passed in my favour. Shukrana Guruji for winning the case.

It was not the end as everybody knows “ Shaitan is always powerful and full of negativity”. But Guruji is Devo ke Dev i.e Mahadev and Supreme power. Nothing is hidden from his eyes.

My Husband has already filed a Divorce case in Saket, South Delhi in June, 2012 i.e why He did not want to meet me in August, 2012. I was not aware of the case as He has not indicated the Mumbai or Delhi address and I did not get the summons. He took Ex-parte divorce on 1st July, 2014. With Guruji Grace, I was able to find out the Case number on July 24, 2014 and the name of the lawyer who find out was “Nirmal” which is name of our Guruji. I filed the Set aside case against the Decree which was passed against me with no fault of mine on 28th July, 2014 in Saket Court as appeal is to be filed within a month. The case was going on but my husband was not realising his mistake and wants to go out of my life. I also filed CRPC 125 maintenance case in November, 2014 in Family Court, Bandra. The first hearing was on 26th March, 2015.

Meanwhile, I got maintenance order from Vikhroli court in December, 2014 so I was relaxed. But my husband file a appeal in Session Court against the order and he was defeated and his appeal was disposed off by Session court. However, he filed appeal in High Court and got the Stay on the maintenance order given by Vikhroli Court in February 21, 2015. He has to deposit Rs. 50,000/- for Bhumika and I have to now fight case in High Court. I was totally shattered. I have completely surrender to Guruji that only you can take out from this. I cannot go the different courts Vikhroli, session court, High Court and Bandra court in Mumbai and Saket court in South Delhi as I am losing money in travelling, court fees and lawyer fees. For fighting the case in High court, Good lawyer was asking the Rs. 1-1.5 lakhs and I can not bear such expenses so I hire the lawyer from Legal Aid. I have done Satsang on March 7, 2015 as the date is to be taken before in hand as there were many sangat. The satsang was very good and I got the feel that your matter will be sorted out within a month. On March 26th, 2015 in Bandra Court the lady counsellor told that you settle the matter yourself whether you want to stay together or not and the settlement amount. There was argument and disagreement and finally lady counsellor has put up the matter on next day instead of next month and settlement deed was finalised on March 27, 2015 in which both the parties have to withdraw respective case and husband will deposit amount in Court as Rs 10 lakhs as lump sum amount as maintenance amount for daughter Bhumika. I got divorced in December, 2015 by Mutual consent and all the cases were withdrawn and I got the Settlement amount in February, 2016 as per the court procedure. During the course of this struggle, my mother and my brother Manish Uncle were pillars of strength. They both stand with me during this battle. Both of them also attended satsangs at Mumbai whenever Guruji’s wishes. Guruji also bless my mother and my brother by giving them langar Prasad. ***“Shukrana Guruji for blessing my family”.***

Guruji watches my patience whether I have greed for money and ego. The sangat is free of filth. Guruji teaches us to build up confidence and Guruji's sangat is always self sufficient. He made his devotees and sangat as Sewadaar. ***Guruji said " kis gal da ahankaar? Neeve ho jao. Neeve ruhan nu hi phal lagde han. Neevi than te jiven paani aap chal ke aanda hai us tarhan hi neeve loga kol blessings aap chal ke aandi hai. Guruji is blessing me since 2012 when I came in refuge of my Guru and protecting me from evil since then.***

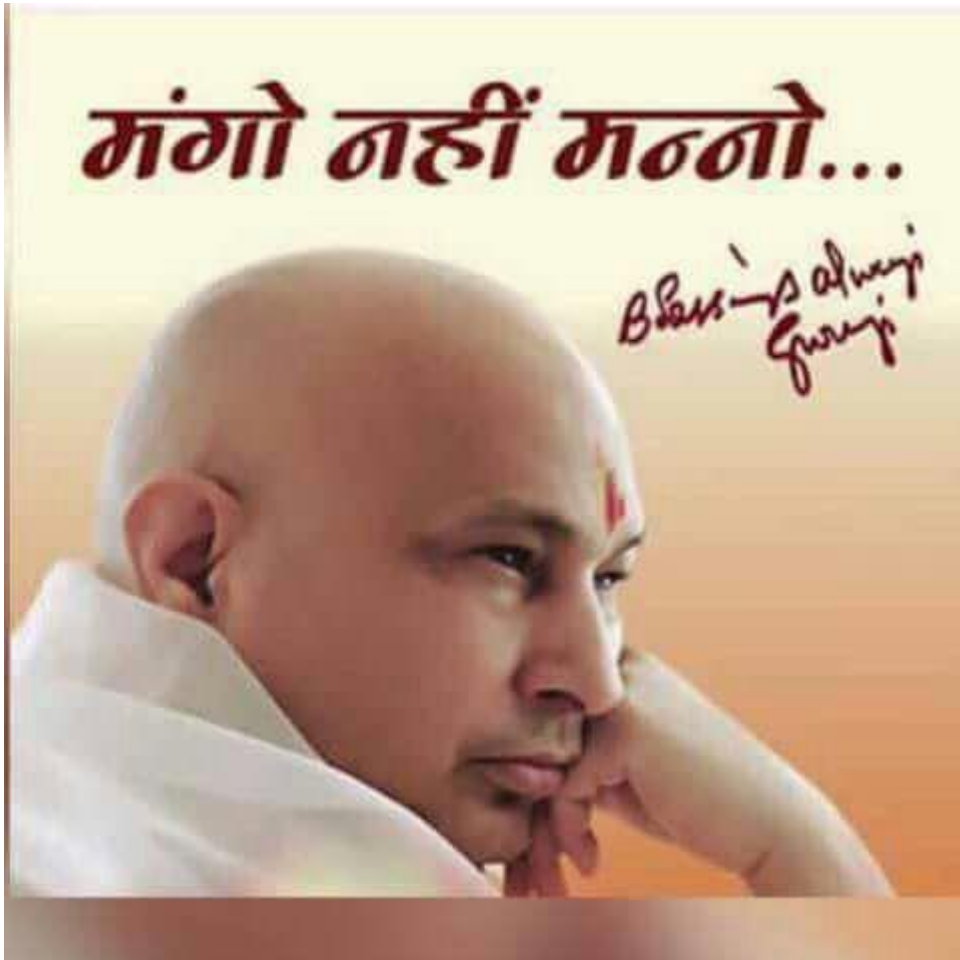
4. Guruji Blesses my Colleagues at Mumbai

I used to get Guruji's Swaroop from the Satsangs and develop and frame them. I used to keep Guruji swaroop in office. I told about my Guruji to everybody and tell the colleagues to attend the Guruji's Satsang. They said if you do satsang at your home then we will come. I have done Satsang on my daughter's birthday 4th June, 2013 and called everybody and it was a blessed birthday for my daughter due to my Guruji's Grace. My daughter Bhumika was very happy. One of my cousin Sister Sweety/Bharti aunty along with her husband and children attended the satsang. Then, I started doing Satsang on every Saturday at my house. Some of my colleagues attended the satsang every Saturday. My colony people also started attending the satsang. One of my colleague Jayshree aunty living in Vidya vihar used to attend the satsang. She felt weakness. She has carried out all possible tests but the disease was not diagnosed. She regularly attended the satsang and have langar Prasad. One day one doctor told her to carry out the test for thyroid and the problem was due to the thyroid. Guruji also blesses her with Ayurvedic medicine given by one doctor who is far away from vidya vihar. But she can travel easily with Guruji Grace without any tiredness every week and the medicine also suits her. She got cured and is healthy now. Another Colleague Ranjana Kulkarni aunty was also blessed. Her only son Kedar Uncle has got posted in Pune. She want that he should come back to Mumbai. Guruji blesses her son in the same previous company at Mumbai with hike and he came back to Mumbai. Another colleague Sunita Ajitkumar aunty was blessed with Car. She used to come to attend satsang from Matunga. One day she felt nausea and thought if I would have car then I could attend the satsang comfortably. Next day her husband company has offered her husband Car from office. Sunita Aunty was very happy. Sunita Aunty has got some psychological problem as she did not able to concentrate in work at office so she decide to resign from the office and gave me her resignation letter as I was Head of Office of the laboratory. I told her that please think over it and take some time to rethink as I will be forwarding it after 7 days. With Guruji Grace as I did not want her to resign, one of my colleague suggested her Doctor to consult. She went with her husband and got the medicine. She got treated well and took back resignation letter. Guruji Blesses her with HIS Grace as Guruji said "**dawai bhi tabhi lagte hai jad mein bless karta ha**". **Shukrana Guruji for blessing the sangat.**

One of my colleague Deepak Gaikwad Uncle, Security Guard was absent for one month without any information. There were reports that he went on leave without information several times and he was not punctual and disciplined from the last several years as per his service records. I being the Incharge of the laboratory was worried and send him letters and told him to join the office immediately and furnish the reason for absence. On 24th August, 2014, there was satsang at my house at Ghatkopar and it was a blessed satsang and one of the sangat has got Guruji divine darshan while sitting in mediation. One of the sangat Pooja

aunty has told me to boil the rose petals at Guruji's Charan and keep it in fridge in a bottle after filtering it. She told me if somebody is ill you can give him/her as medicine it is very effective. I did the same but not able to understand the Guruji's Mahima. Next day on 25th August, 2014 I went to office then Gaikwad's wife and son came to office and informed me that he is very ill and is in ICU in Kohinoor Hospital at Kurla, Mumbai. They got my letter and I told his son to give me reply and submit the reports. He has to undergo the heart operation for which they need Rs 5 lakhs. I told her wife and son to calm down and told him to come to my house and give the Guruji's Charan Rose Petal Syrup to his father. His son gave him and within two days, he was out of ICU and came home. It is such a great Guruji Mahima and Blessing for Him. I wrote letter to my head office for funds for his operation. Meanwhile he was coming to office regularly and I gave him Guruji Book "Light of Divinity". He read out the whole book. He got the operation done and operation was successful. ***Guruji blesses him a new life. Shukrana Guruji aapka. Har swaas ka Shukrana. Har vele Shukrana. Jai Guruji. Dhan Dhan Guruji. Wah Wah Guruji.***



5. Guruji Blesses my daughter Bhumika

My daughter Bhumika was staying with me since she was 4 years old. I was staying alone at Mumbai as my parental family i.e my mother and brothers are staying at Delhi and my husband has left me. I have to perform official duty and take care of her. Guruji blesses daughter Bhumika with the love of sangat which is utmost required for a minor child and best of day care and maid. Guruji always prefer the child should be reared by family member/people with positive energy and thoughts.

Guruji satsangs at my home removes all the negative people in my life and my daughter's life. My cousin sister Kavita aunty, sweet/bharti aunty used to travel to Mumbai and taking care of her. Guruji has made one of my colleagues i.e Usha aunty as my homemate after her retirement. She retires in March, 2013 and was staying in Ghatkopar opposite to my Quarter. She was working in Regional Office at Mumbai. Her Quarter can be extended upto 8 months as per Govt. rule. So, she stays in her quarter upto November, 2013. She was worried where she will go after 8 months, she has to find out some rented place. On 17th November, 2013 Guruparv, Guruji's satsang was at my place at Ghatkopar. She attended the satsang. After the satsang, she shared the problem with me and I suddenly said to her "You shift at my place". She shifted immediately after Satsang and vacated her house and handed the quarter to CPWD and got No due certificate.

She used to attend the Guruji's satsang as I have told her about Guruji. We go together in Car wherever the Satsang take place in Mumbai. She takes care of Bhumika well as her grand-daughter and love her so much. She stayed up to May 2014 and shifted to her hometown Nagpur. Meanwhile her all dues gratuity, retirement dues etc came and she closed all the accounts and she constructed one floor at her Nagpur house and finally shifted to Nagpur. *Guruji Blesses Usha aunty as well as Bhumika i.e my daughter and in turn me. Shukrana Guruji for your immense blessings.*

6. Guruji take care of my emotional needs and Blessed me with HIS Divine Darshan

I got the answer from that Guruji's dream why all this happen in my life. It gave me immense peace in the mind and made me relaxed.

I used to go in satsangs in Mumbai and sangat share the satsangs that they had got Guruji Darshan. I used to ask Guruji when you will give me Darshan. **Guruji gave me "Divine Shivji Darshan" in March 2013 and I saw the light that transform into Shivji.** It was very strong. When I wake up, I got scared. Guruji says "I am light". I am Shivji". I am Mahashiv". Shukrana Guruji for blessed darshan. Guruji again gave me darshan as if HE is putting oil on my head and say me *mein hu na chinta na kar*. Guruji gave me OM darshan also. I have kept a plate in my office for Guruji and I used to offer Lunch to Guruji in my office in that plate and then eat the prasad afterwards. OM is engraved in the steel plate as if it is made with a machine and is still on the plate. Shukrana Guruji. OM darshan was also given by Guruji in one the floor of my house at Ghatkopar after the Satsang at Guru Parv in November 2013.

8. Guruji extends my Stay in Mumbai

On 8th September, 2015 I have received letter from Head office, Faridabad that I have been transferred to Nagpur and I have to join the office with immediate effect. I was shocked to see the letter as I have not been intimated or have any clue for this. I have to withdraw the cases i.e High Court, Bandra Court at Mumbai and Saket Court, South Delhi cases which were pending. Bhumika has school and immediate shifting was not possible. I prayed to Guruji and Guruji gave me hint that you send a representation and ask for extension up to March 2016. But Head office gave me extension upto 31st December, 2015 and I have to join Nagpur office on 1st January, 2016. Guruji also gave me opportunity to do seva at Kandivali, Mumbai mandir during my extended period. I love Sewa. I am getting far away from the Mumbai Mandir as I was transferred to Nagpur. I used to do either Langar Sewa or Pantry sewa whatever is assigned to me and feel blessed at Mumbai Mandir. There is a big satsang on 31st December, 2015 and I have to join the office. I just prayed to Guruji " You don't want me to attend the Satsang at Mumbai and want me to travel to Nagpur". Immediately, one of my college told me to talk to Head of Department, Joint Secretary cum Agricultural

Marketing Adviser to Govt. of India. I told him my problems. He told me to file case in CAT. But I told him why should I file case as I am fed up of cases and when I am approaching you to consider my representation and extend my stay upto March, 2016. He smiled and told me “ok” send the e-mail to me, I do. I stayed upto 31st March, 2016 at Mumbai. I got divorced in December, 2015 and high court case was also withdrawn by my husband. Bandra court case was withdrawn in February, 2016. Bhumika’s school was also up to April, 2016. I have applied for extension of Quarter at Mumbai also for her stay. I don’t want to go from Mumbai as I was regularly attending the satsangs there and felt blessed and safe. Nitin Uncle once said that aunty Guruji wants to extend the sangat at Nagpur and you start satsang at Nagpur which I feel Guruji is giving me Sewa and establish his mahima at Nagpur.

Then I started Guruji's Satsang monthly at my place. Guruji is blessing the sangat who is coming to attend the satsangs. I feel very blessed in Guruji's sharan.

Guruji's Blessings are immense and I want to Share some of HIS Meher in coming paragraphs.

- a) My daughter Bhumika has passed with good marks and is studying well for the last four years. I am also giving her time on her study as I have mental peace due to no court case and mental stress. Both of us are living together with Guruji's Meher and with mental peace.
- b) I started driving my car myself. I purchase car in 2012 and have not driven the car as I was scared. I learned two-three times, I never drive myself at Mumbai. I used to go to my office at Nagpur with Car. Shukrana Guruji for your blessing.
- c) **Guruji's saved my life**. I have got Car Accident in November 23, 2016 and my car droved down a hill as I am Living at Seminary Hill. I was going to office in the morning. Suddenly my bumper was opened and it struck in tyres . I thought of taking reverse and want that I will keep the car at home and go by auto. But on reversing the car went towards downhill. I did not have a single scratch as I said "Guruji" when car was going down. I want to cry at that moment but Guruji does not want me to cry even. Help came and people surrounded me and two boys and one lady lifted me up safely. Police help also came and I made complaint and got the insurance claim. Maruti Insurance has made a budget of Rs 1,60,000/- for repair and insurance company told that they will give 40,000/- and rest amount to be paid by me. I was not having that much amount so I prayed to Guruji for help. I thought of selling the car. But with Guruji's Grace, one of the neighbour Rajni aunty told me to talk to the Insurance company. I had meeting with insurance company and I told them to repair the car with their authorised workshop. The authorised dealer M/s Kedia at Nagpur has repaired the car and I have to pay Rs 51,000/- and the car become brand new instead of Rs 1,20,000/-" ***Shukrana Guruji for saving my life and blessing me and my family***".
- d) Guruji helped me to get my daughter Bhumika admission in Kendriya Vidyalaya at Vayusena Nagar in 2019 which is near to my house.

- e) Guruji blessed me a 1 BHK DDA Flat at Rohini, Delhi. I applied in 2017 and in February, 2018, my name appeared in list and with Guruji's Grace, I got possession in December, 2018 and got conveyance Deed registered in November, 2019.

She went to develop the Guruji's swaroop for Satsang and the shopkeeper told her, there is one aunty "Kapoor aunty" who used to do Guruji's satsang at Nagpur. She immediately took her number and called her. She told there is another group of Guruji's Sangat of around 30 people. She informed me and invited her all to join our group and attend the satsangs. All came and we were very happy to have 50 people attending the satsang. Then there is no looking back, we keep on adding the people and Guruji's Mahima is increasing day by day. Besides this we have made a Management Committee comprising of 7 members who used to manage each satsangs and helping the new sangat to carry out the satsangs at their home.
